What is OnBoardGOV?

OnBoardGOV is an open government solution.

Allows citizens to apply for board seats online.

Allows staff to update board members contact information, membership, run term expiration reports, and so much more.



Why an online application process?

- Existing process – manual process, paper heavy, consumes staff time
- On-line applications:
 - ▶ eliminate paper applications
 - ▶ individualized board-specific application questions
 - ▶ efficient seat management with contact information, adding / removing members, historical records, etc.
