- 4. Concrete Maintenance Project repair 75 sidewalk locations, replacement of ramps at 10 intersections.
- 5. Chip Seal Project chip sealing of 54 streets. Improvements made to specifications to improve performance.
- 6. Slurry Seal Project pilot program to be used on 3 streets to study performance and determine future usage.
- 7. Western Ave Culvert Replacement replacement of failing culvert under Western Avenue.

- That the City of Brookings, South Dakota shall provide a minimum of 50% of the total cost of the project; and will assume all responsibility in the operation and maintenance of the project upon completion of construction, for the reasonable life expectancy of the facility.
