City Manager Paul Briseno, City Attorney Steve Britzman, and Deputy City Clerk DeShawn Scott were also present.

<u>Agenda.</u> A motion was made by Council Member Wendell, seconded by Council Member Tilton Byrne, that the agenda be approved. The motion carried by the following vote: Yes: 7 - Niemeyer, Wendell, Avery, Tilton Byrne, Specker, Doran, and Rasmussen.

A. Action to approve the May 9, 2023 City Council Minutes.

B. Action on Resolution 23-051, a Resolution in support of an Application for Financial Assistance to the South Dakota Housing Development Authority by Branch Creek, LLC, and / or its Affiliates, Agents, or Assigns, for the Benefit of Multi and Single-Family Development.

Resolution 23-051 - Resolution in Support of an Application for Financial Assistance to the South Dakota Housing and Development Authority by Branch Creek, LLC, and / or its Affiliates, Agents, or Assigns, for the Benefit of Multi or Single-Family Development

Whereas, the City of Brookings and Branch Creek, LLC have determined it is necessary to proceed with improvements to the City's infrastructure, thus enabling additional single and multifamily units to be constructed in the city limits of Brookings; and

Whereas, the City and Developer have determined financial assistance will be necessary to undertake the Project and an application for financial assistance to the South Dakota Housing and Development Authority shall be prepared by Branch Creek, LLC (Developer) for the proposed development; and

Whereas, the City will work with the Developer's engineer to ensure the preliminary project infrastructure plans meet the City's requirements for adequate drinking water, water treatment capacity and distribution, storm sewer, and all other necessary improvements as needed; and

Whereas, the City has adequate treatment facilities and water supply to accommodate the proposed development; and

Whereas, the City is committed to the ownership and long-term maintenance of said

infrastructure upon acceptance and the conditions set forth in the certificate of completion that the said infrastructure and system shall meet the specifications, materials and equipment set forth as shown on the approved plans in said agreement; and

Whereas, the 2022 Brookings County Housing Study identified the need for additional owner-occupied housing in the moderate to market price range, an increase in the variety of housing types, designs, and densities; and

Whereas, the City acknowledges that there is a significant housing shortage in City of Brookings and this proposed development will help, but not resolve the housing shortage.

Now, Therefore, Be It Resolved by the City of Brookings as follows:

- 1. The City hereby supports the submission of an Application for financial assistance by Branch Creek, LLC, to the South Dakota Housing and Development Authority.
- 2. City officials of the City of Brookings are hereby authorized to deliver such other documents as necessary, to assist with the Application.

Whereas, Global Accessibility Awareness Day (GAAD) is commemorating its 12th Anniversary of educating about digital access and inclusion for the more than one billion people with disabilities; and

Whereas, GAAD is led by the GAAD Foundation, which was founded on the 10th Anniversary of Global Accessibility Awareness Day and whose mission is to disrupt the

culture of technology and digital product development to include accessibility as a core requirement; and

Whereas, workplaces welcoming of the talents of all people, including disabled people, are a critical part of our efforts to build an inclusive community and strong economy, yet more than 98.1% of corporate and organizations home pages have at least one Web Content Accessibility Guidelines 2.0 failure, thus making it difficult with those members of the disabled community from fully accessing information.

Now, Therefore, Be It Resolved, that I, Oepke G. Niemeyer, Mayor of the City of Brookings, do hereby proclaim May 2023 as Global Accessibility Month, and I call upon employers, schools and other community organizations in Brookings to observe this month with an appropriate review of their digital content, and to address issues identified in such reviews that prevent disabled people from accessing and using digital content provided by these institutions.

Whereas, these entities in Brookings have been working tirelessly for LGBTQ2S+ awareness and equality: Human Rights Commission, Brookings PFLAG, Brookings Public Library, Brookings Arts Council, and Brookings Pride; and

Whereas, the Brookings community will be celebrating Pride on June 3rd at Pioneer Park.

of Brookings, do hereby proclaim June 2023 as LGBTQ2S+ Pride Month.

Whereas, the City of Brookings is the owner of the Swiftel Center, a premiere public entertainment and meeting facility ("facility") located in the City of Brookings; and

Whereas, OVG360 is the Management Firm retained by the City of Brookings to manage the Swiftel Center; and

Whereas, Dacotah Bank is a South Dakota banking, mortgage and trust, wealth management and financial services firm with locations in Brookings and throughout northeastern South Dakota; and

Whereas, consistent with the goals of the City of Brookings' Strategic Plan, OVG360, the Swiftel Center Advisory Board and the City of Brookings have explored proposals for a new naming rights partner for the Swiftel Center; and

Whereas, a proposed Naming, Advertising and Sponsorship Agreement has been developed which provides, in part, for naming, advertising and sponsorship opportunities, including the naming rights for the Swiftel Center, for Annual Fees of \$150,000 over a 10-year period; and

Whereas, the City of Brookings believes that naming its facility Dacotah Bank Center and entering into a long term agreement with Dacotah Bank will be mutually beneficial to both the City of Brookings and Dacotah Bank.

Now, Therefore, Be It Resolved by the City Council of the City of Brookings, that the City of Brookings enter into a Naming Rights Agreement with Dacotah Bank, and that the City Manager is authorized to execute the documents in accordance with this Resolution.
