RESOLUTION 24-016 - RESOLUTION DETERMINING THE NECESSITY OF REPAIRING OR INSTALLING SIDEWALKS IN THE CITY OF BROOKINGS AT THE EXPENSE OF ABUTTING PROPERTY OWNERS; 2023-01SWR CONCRETE MAINTENANCE PROJECT

BE IT RESOLVED by the City Council of the City of Brookings, South Dakota, as follows:

1. It is hereby determined that sidewalk repairs or installation is necessary abutting the parcels and lots of land in the City described in the Notice to Property Owners attached to this Resolution and marked as 2023-01SWR Concrete Maintenance Project.

- 2. Such sidewalks shall be installed to the width and of the materials prescribed by Chapter 74, "Streets, Sidewalks and other Public Places" and Article V. "Sidewalks", and to the grade and in accordance with the Plans and Specifications prepared in the office of the City Engineer.
- 3. The method of apportionment of benefits is as follows: such assessments, unless paid within thirty (30) days after the date of mailing of a statement of account by the City, shall be collected by the City in accordance with the procedure for Plan One in Section 9-43-102, South Dakota Compiled Laws of 1967, as amended, with interest of 7.98% set by the City's Special Assessment Policy on the unpaid balance. Assessments amounting to less than \$300.00 shall be paid in one payment.
- 4. The City has caused a copy of the Resolution and a Notice to Property Owners to be mailed to each property owner by certified mail.

Resolution 24-017. A public hearing was held on Resolution 24-017, a Resolution authorizing the City Manager to enter into an On-Off Sale Wine Operating Agreement for MG Oil, dba Corner Pantry #24, Troy Erickson and Marlyn Erickson, owners, 600 6<sup>th</sup> Street, Brookings, South Dakota, legal description: Lots 5-7, Block 11, Second Addition. BE IT FURTHER RESOLVED that the City Manager be authorized to execute the Agreement on behalf of the City, which shall be for a period of 10 years, with a 5-year mid-term renewal.
