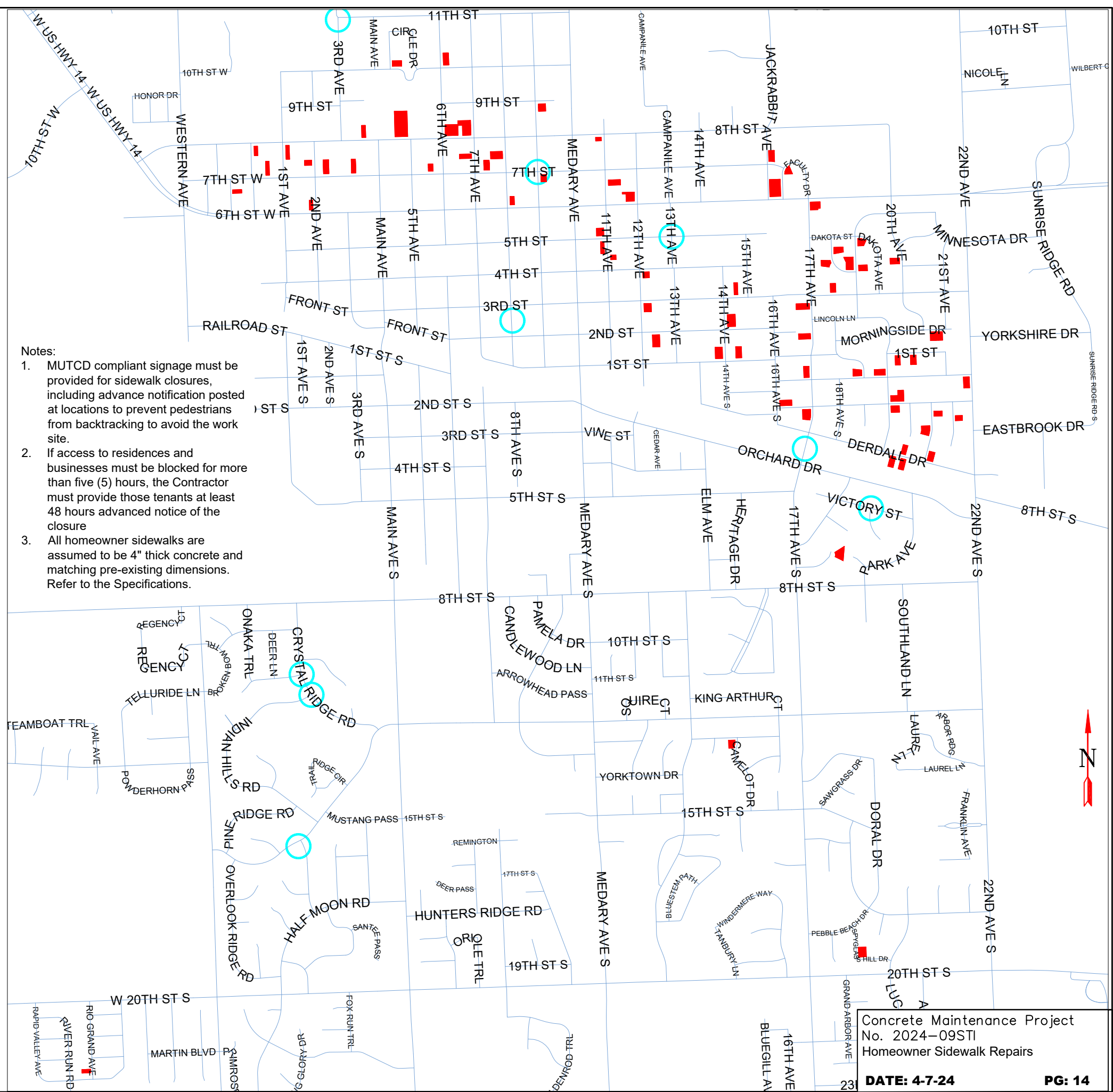

- Notes:
- MUTCD compliant signage must be provided for sidewalk closures, including advance notification posted at locations to prevent pedestrians from backtracking to avoid the work site.
  - If access to residences and businesses must be blocked for more than five (5) hours, the Contractor must provide those tenants at least 48 hours advanced notice of the closure
  - All homeowner sidewalks are assumed to be 4" thick concrete and matching pre-existing dimensions. Refer to the Specifications.
