### Video Lottery

CITY OF BROOKINGS (JUNE 2023)

Only establishments which hold an on-sale alcohol license may qualify for Video Lottery. (SDCL 42-7A-1(6) / 42-7A-37.1)

This includes businesses with malt beverage and wine licenses, which do not hold on-sale operating agreements.

### Alcohol License Holders within City

#### Alcohol Licenses which allow video lottery

- 1) On-Off Sale Malt License 59 license holders
- 2) On-Off Sale Wine/Cider License 24 license holders
- 3) On-Sale Liquor License 18 license holders (quantity limited by SDCL)


#### Alcohol Licenses which do not allow video lottery

- 1) Off-Sale Liquor License
- 2) Temporary / One-Day Special Event Licenses
- 3) On-Sale Restaurant Liquor License 2 license holders
- 4) On-Sale Convention Liquor License 2 license holders (quantity limited by SDCL)

### Criteria for placement a Municipality may consider for authorizing video lottery establishments SDCL 42-7A-64

- 1) The number of establishments currently licensed for video lottery.
- 2) The proximity of the business to other establishments licensed for video lottery.
- 3) The type of business and manner in which it will be operated.
- 4) The location of the business in relation to other businesses, residential areas, or activities within the same general area.
- 5) The extent to which minors frequent a business connected to the proposed.
- 6) The effect the proposed business has on economic development.

Location of existing businesses with video lottery. Colors on the map indicate zoning.



### **Application of SDCL 42-7A-64**

(criteria for Video Lottery establishments)

- 1) The manner a City can influence video lottery placement is by application of the six criteria, and after applying the criteria, the City may approve or deny an application for video lottery placement.
- 2) A municipality may influence video lottery placement at one time only at the time the licenses are applied for.
- 3) Municipalities may consider the number of establishments in the City currently licensed for video lottery.

# Application of SDCL 42-7A-64 (criteria for VL establishments)

- 4) Municipalities CAN apply the criteria and deny any application for a video lottery application.
- 5) Municipalities CAN approve an on-sale alcohol license, and DENY a video lottery license request.
- 6) Existing video lottery licenses MAY NOT BE DENIED renewal or transfer based upon the criteria set forth in SDCL 42-7A-64.
- 7) MAY NOT restrict the number of establishments certified for video lottery to a number less than those licensed as video lottery establishments on March 1, 1994.

# Other Cities' Restrictions of Video Lottery Establishment Authorizations

#### Sioux Falls (population 196,528)

- 186 authorizations for the first 202,600 population
- 1 authorization per each 5,000 population

### Rapid City (population 76,184)

- 75 authorizations for the first 74,000 population
- 1 authorization per each 2,000 population

# Other Cities' Restrictions of Video Lottery Establishment Authorizations

#### Aberdeen (population 28,324)

Maximum authorizations shall be 35

### Mitchell (population 15,631)

- No authorization for on-sale wine licenses
- No authorization for on-sale malt beverage licenses
- No restrictions for on-sale liquor licenses

### **Proposed Ordinance**

Limit the number of video lottery machines in the City based on population.

24 authorizations for the first 23,377 population.

One authorization for placement, as per SDCL 42-7A-64, may be granted for each additional 1,000 of population.
