**Subject:** Acceptance of Solid Waste Master Plan

# **Summary:**

The Solid Waste Master Plan Committee and HDR, Inc., worked over the past 13 months to develop Brookings' first Solid Waste Master Plan (Plan). The Plan was presented to City Council at the September 19, 2023 Study Session. Staff is recommending City Council accept the Plan.

# **Background:**

In August 2022, the City of Brookings contracted with HDR, Inc., to develop a 10-year Solid Waste Master Plan. The scope of the work included the evaluation and analysis of the Solid Waste Division's operations, current facilities, and financial health; then identify critical short-term and long-term needs, and provide key information for stakeholders and City policy makers to provide direction on program decisions, and guidance for sustainable, long-term solid waste operations. To achieve these objectives, the consultant collected and analyzed data from a variety of sources including (2) two public stakeholder meetings. The Plan will be utilized as a resource and road map to guide the Solid Waste Division's operations, budget and capital improvement plan.
