**Subject:** Video Lottery Authorization: South Main Casino & Pub,

Suite B

### **Summary:**

The City of Brookings has received a request for a Video Lottery authorization for South Main Casino & Pub, Suite B, SVK Properties, Todd Voss, owner. All required documents have been submitted.

#### Background:

A public hearing and action by the local governing body is required. This license would be effective upon State Lottery Office approval and license issuance, and subject to annual renewal.

This business is located at 615 Main Avenue, and is proposed to hold 2 Suites, each with an On-Off Malt License, with up to 10 video lottery machines in each suite.

The Council approved Ordinance 23-020, which established the number of video lottery authorizations in the City. As per Ordinance, there are 30 authorizations available for the first 26,377 population. The two video lottery requests on tonight's council agenda will reduce the remaining number of available authorizations to one. No additional authorizations will be granted until the population of the City of Brookings reaches 27,377 (one authorization granted for each additional 1,000 of population).

#### Item Details:

South Main Casino & Pub, SVK Properties, Todd Voss, owner, has applied for an On-Off Malt License, with video lottery authorization, for Suite B located at 615 Main Avenue. This would allow 20 video lottery machines at this location.

This location will be remodeled to add an additional suite (Suite B) for video lottery, holding up to 10 video lottery machines. In order to satisfy State Video Lottery Regulations, there must be separate and distinct physical facilities maintained and utilized for the sale and consumption of alcoholic beverages for each separately described premises.

Their plan indicates the separate spaces have been designated, and sales and consumption of alcoholic beverages are intended to occur at these 2 locations within the

building. This would comply with the video lottery requirements if the City Council approves the additional On-Off Sale Malt Licenses and if the City Council also approves Video Lottery for this additional location within the building.

**SDCL** <u>42-7A-64</u>. Additional criteria for on-sale alcoholic beverage licensees in video lottery licensed establishments. A municipality or county may consider, in addition to the criteria for the issuance of an on-sale alcoholic beverage license, the following criteria for authorizing video lottery machine placement in establishments issued an on-sale alcoholic beverage license pursuant to subdivisions 35-4-2(12) and (16):

- 1. The number of establishments currently licensed for video lottery;
- 2. The proximity of the business to other establishments licensed for video lottery;
- 3. The type of business and manner in which the applicant proposes to operate it;
- 4. The location of the business in relation to other businesses, residential areas, or activities within the same general area;
- The extent to which minors frequent a business connected to the one proposed; and
- 6. The effect the proposed business has on economic development.

The governing board shall certify on each application filed with the Department of Revenue for a license granted under subdivisions 35-4-2(12) and (16) whether the business premises is authorized for video lottery machine placement. An existing video lottery license may not be denied renewal or transfer based upon the criteria set forth in this section. The lottery may issue a video lottery license to those establishments certified pursuant to this section. Notwithstanding the above provisions, a county or municipality may not restrict the number of alcoholic beverage licenses issued under subdivisions 35-4-2(12) and (16) and certified for video lottery to a number less than those licensed as video lottery establishments on March 1, 1994.
