OFFICIAL SUMMARY

Chairperson Tanner Aiken called the meeting of the City Planning Commission to order on Tuesday January 7, 2020, at 6:00 PM in the Chambers Room #310 on the third floor of the City & County Government Center. Item #4a – This is a final plat to create two residential lots and one lot for common area in “The Landing” development. The lots represent the foundation permits of the homes.

Item #5a – Bungard reviewed the 2019 Draft Annual Report. The Joint Jurisdiction Zoning Ordinance is currently being worked on and should be implemented by end of year 2020. The Design Guidelines/Overlay District process is currently being worked on by staff. The Connectivity Index continues to be in progress and worked on. The Residential Parking study was complete in 2019.

Rasmussen wondered if the board had made any action on the Parking Study results. Struck recalled that there wasn’t any motion. Due to recent implementation of parking for complexes of 25 units or more, it was decided that nothing should be changed yet because there hasn’t been enough time to see the effect of those changes.

Fargen asked if there were areas other than 6th Street that were being looked at during discussion with the Design Guidelines Manual/Overlay District. Struck stated that there are a couple of other areas, the gateways to the City.

Pierce recalled that the Comprehensive Plan had recommendations that the Commission was supposed to look at annually. She wondered if staff looked at these recommendations. Struck explained that staff looks at the Comprehensive Plan regularly and they have found areas that will need some updating.
