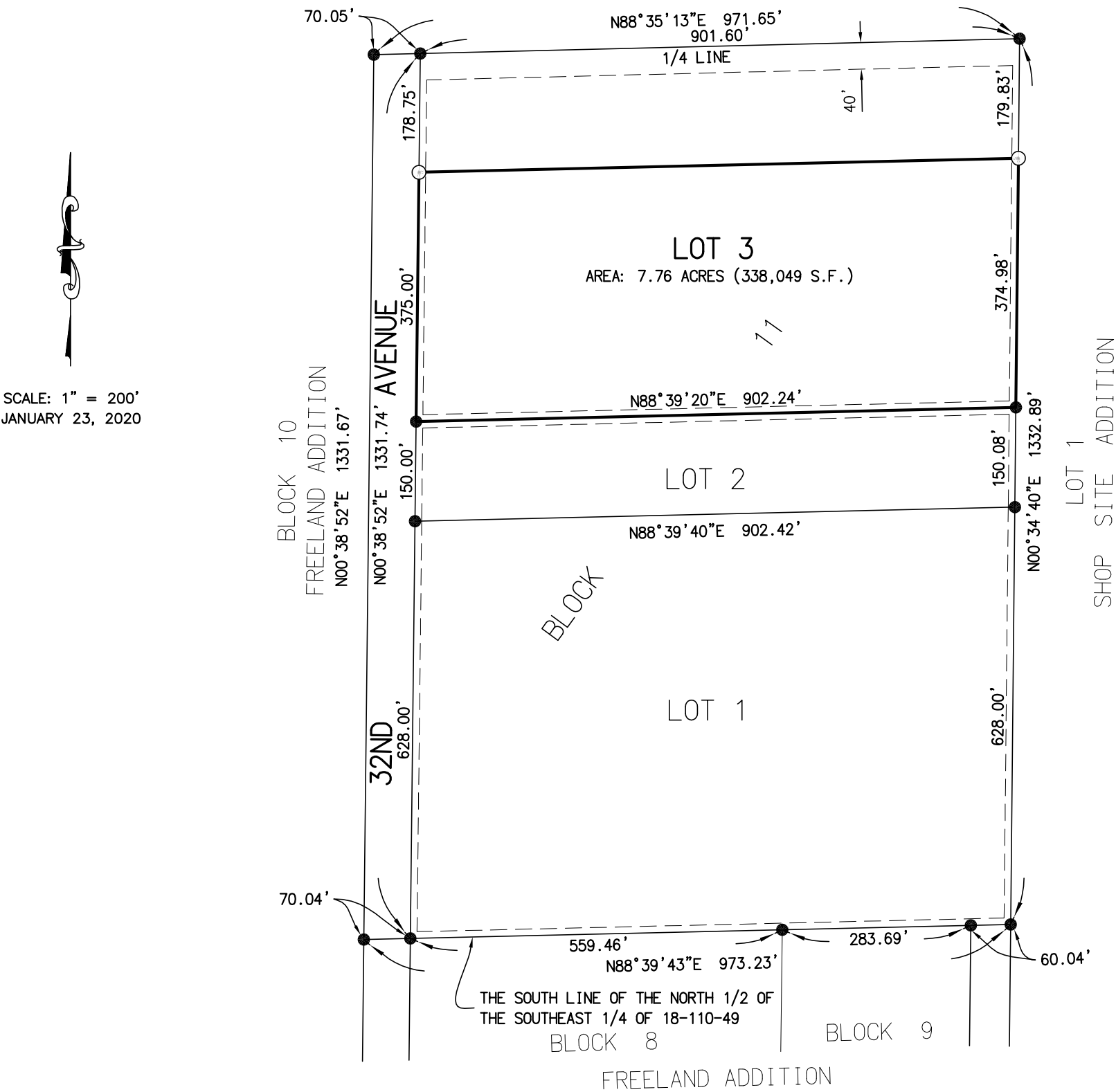


PLAT OF
