Thank you for the opportunity to comment on the above referenced project pursuant to SDCL 1-19A-11.1. The South Dakota Office of the State Historic Preservation Officer (SHPO) would like to provide the following comments concerning effect of the proposed project on the non-renewable cultural resources of South Dakota.

On April 3, 2020, the SHPO received notification of the above-referenced project to replace

one window on the back (west side) of the building at 721 Medary Ave in Brookings. Given that the window to be replaced is in a later addition and is not visible from the public right-of-way, the SHPO has determined that the proposal will not encroach upon, damage, or destroy historic properties listed in the National or State Registers of Historic Places.
