Motion by Merriman, second by Heiberger that BHPC would like to further review options to include potential for preservation and for replacement in kind of the two front windows and the action is tabled until the following information can be obtained:

- For potential of preservation, BHPC would like to see evidence from a contractor that preservation of the windows, to include returning their functionality, is not feasible.
- For replacement in kind, the BHPC would like to see information and drawings on a product that more closely mimics the character defining features of the existing windows, to include the dimensions and presence of multiple frames for the window frame and storm window or screen casing, and to preserve the proportion of the tracery (grill) so that it remains consistent with that of the existing windows.

In response to the request for additional information;

- The existing window shown in the attachment has opening dimensions, where the storm window is, as 34.25 inches by 59.25 inches. The proposed replacement, as shown on page 4 of the Kolbe specifications per the attachment on the original application, is 35.5 inches by 60.437 inches. The difference in size is 1.25" in total width by 1.187" in total height. That is 5/8" per side and 19/32" top and bottom in difference.
- The new south window shown in the attachment is, not surprisingly, exactly the same size.
- The difference with the replacement on the south and the replacement on the east is that the new east would incorporate an outside protruding "sill" at the bottom, same size and appearance as the existing. The panes shown on the existing south are a separate grill that can easily be 4 pane vs the 3 pane shown.
- The additional comments below, from Midwest Glass and Built Rite Construction, provide further evidence of our efforts and intentions.
- The work will be done by Robbins Construction who did the kitchen remodel and the bedroom window replacement projects.
- We feel the replacement windows will result in achieving our overall goal of maintaining the historic appearance as well as the functionality of our home.
