

Resolution No. 5-17-2021

A Resolution Approving Jurisdictional change of a part of 214th Street

Be It Resolved by Aurora Township, South Dakota, as follows:

Whereas, the City of Brookings (hereafter "the City") is constructing an Interstate 29 Interchange at 214th Street, otherwise known as 20th Street South, and

Whereas, the City is currently planning, financing and preparing for the street improvements necessary at 214th Street to improve transportation, drainage and safety to accommodate traffic at the future interchange at 214th Street, and

Whereas, SDCL §31-17-7 sets forth the procedure for assignment of responsibility for boundary line highways between organized townships and SDCL §9-45-1 authorizes a municipality to construct, maintain and repair roads within its jurisdiction, and

SDCL 31-17-07 authorize a majority of supervisors of adjoining townships to mutually agree to alternative procedures for apportioning the responsibilities and costs of constructing, altering or repairing any township boundary line highway, bridge or culvert. In addition SDCL 31-17-16 allows a municipality to accept assignment of responsibility of a township boundary line highway, and

Jurisdictional control will allow the City of Brookings to plan, finance and construct the street improvements on 214th Street, which are necessary to improve transportation, drainage and safety to accommodate current and future growth with the BUILD Grant for the Bridging the Interstate Divide project, and

Whereas, 214th Street, otherwise known as 20th Street South, from approximately Twelve Hundred Thirty Feet (1,230') west of Interstate to approximately Two Hundred Fifty Feet (250') east of 34th Avenue is currently under the jurisdiction of Aurora Township, and

Whereas, the purpose of this resolution is request the transfer of jurisdictional control from Aurora Township to the City of Brookings for the following areas:

Southwest Quarter (SW ¼), except Lot H-4 in Section Thirty-One (31), Township One Hundred Ten (110) North, Range Forty-Nine (49) West of the 5th P.M., Brookings County, South Dakota and

The West Eight Hundred Thirty-Seven Feet (W837') of the South Five Hundred Twenty and Forty-Three One Hundredths Feet (S 520.43') of the Southwest Quarter (SW ¼) of the Southeast Quarter (SE ¼), except Lot H3 thereof, Section Thirty-One (31), Township One Hundred Ten (110) North, Range Forth-nine (49) West of the 5th P.M., Brookings County, South Dakota and


Southeast Quarter (SE ¼), except the West Eight Hundred Thirty-Seven Feet (837'), of the South Five Hundred Twenty and Forty-three One Hundredths Feet (S 520.43') thereof, except Tracts A & B Wetland Easement, LG Everest Addition thereof, except Lots H1 and H3 thereof, and except the Railroad Right-of-way thereof, all in Section Thirty-One (31), Township One Hundred Ten (110) North, Range Forty-nine (49) West of the 5th P.M., Brookings County, South Dakota and

South Half (S ½) of the Southwest Quarter (SW ¼) except Lot H1 thereof, and except the Railroad Right of Way thereof, in Section Thirty-Two (32), Township One Hundred Ten (110) North, Range Forty-Nine (49) West of the 5th P.M., Brookings County, South Dakota.

Now, Therefore, Aurora Township hereby requests the jurisdictional transfer for the parts of 214th Street described in this Resolution pursuant to applicable law, thereby including the above-described highways within the jurisdiction of the City of Brookings for the construction and future maintenance of the parts of 214th Street described herein.
