- Brookings Solar Project.

- MRES purchased 80 acres located southwest of the landfill.
- Construction is planned to start as early as fall 2023, constructing solar panels to produce a minimum of 5 MW's.
- 2025 construction the energy created from this project will be directly utilized within the city.
- Long term effects of the solar initiative will offset the cost of

electricity within the city.

- The project is set to be operating by the summer of 2025.
