### **CEO Report**

### **CFO Report**

Wagner noted Business Office Director, Grant McAdaragh, has resigned his position and recruitment for his replacement is underway. Wagner also provided a summary of funding opportunities Brookings Health is eligible for as well as Grants received thus far. Most recently, the Small Business Administration re-opened the emergency loan program (Paycheck Protection Program) to government owned/municipal hospitals and an application will be submitted as soon as possible. There may also be new legislation that would allow forgiveness for the CMS Accelerated and Advance Payment Program which provides upfront funding based on 100% of Medicare payments for the previous six months.

Hillestad noted, extensive preparation and planning has taken place on the most efficient way to care for COVID positive patients. The C-19 Response Team is represented by several departments that have been working together on triage guidelines and management of a potential COVID-19 surge. To make the best use of Personal Protection Equipment (PPE), an internal process has been implemented that will allow us to decontaminate N95 masks for use up to five (5) times.

# **Board Committee Reports**

### **Administrative Committee Meeting**

Committee member Wosje provided a report; the Administrative Committee met on April 21, 2020. Topics of discussion included Meditech Expanse, Brookings Futbol Club Indoor Facility, Brookings Health System's Strategic Plan, and COVID-19.

Merkley provided further details to members regarding the partnership opportunity and donation request from the Brookings Futbol Club (BFC). Brookings FC is requesting a financial commitment of \$200k in capital along with a long term lease to occupy 2,500 sq. ft. of space in an indoor training facility. Brookings Health's intent would be to develop a sports enhancement program and house our Cardiac Rehabilitation program in the facility. Additional stipulations for the sponsorship were reviewed and will be provided back to BFC. Consensus was this would benefit the community as well as other parties involved.

A motion was made by Wosje, seconded by Anderson to proceed with the \$200k commitment if BFC is in agreement with Brookings Health System's stipulations and deliverables.

#### Finance Committee:

Committee Chair Peterson provided a report; the Finance Committee met on April 23, 2020. The committee reviewed and approved the payables, financials and adjustments for March. Discussion also took place regarding relief funds from the CARES Act and reduced staffing hours.

Committee Chair Ellsworth provided a report; the Quality Committee met on April 21, 2020. Topics of discussion included 2019 Patient and Resident Safety, Q4 2019 Patient Satisfaction, Patient Experience Campaign Heart of Caring, and COVID-19.

#### **OLD BUSINESS**

### Rural Community Hospital Demonstration (RCHD) Program

Due to the COVID-19 pandemic, the RCHD extension is on hold for the time being as we continue to address COVID-19 legislative concerns and relief. Merkley will inquire with the American Hospital Association (AHA) for further details. The RCHD Program is scheduled to expire on October 1, 2020 for Brookings Health System.

# **Brookings Health System Strategic Plan**

Merkley noted, as discussed at the Administrative Committee Meeting, the strategic plan will be put on hold until further notice. Operational focus and board leadership discussions will center on recovery planning from COVID-19.

#### **NEW BUSINESS**

### **Medical Staff Credentialing**

A motion was made by Ellsworth, seconded by Peterson to approve the credentialing and recredentialing as recommended by the Medical Executive Committee.

### **Q4** 2019 Performance Dashboards

A snapshot of performance numbers for Q4 2019 for Brookings Hospital and The Neighborhoods at Brookview was provided. Overall, trends were positive through 2019 with a few areas of opportunity.

#### COVID-19

As mentioned previously, Brookings Health released its bed management/surge capacity plan to the Brookings Register to inform the community how we plan to take care of a surge of patients if and/or when the need arises. The virus peak for Brookings County could be mid-June and we are preparing for this to be the case. The C-19 Response Team did a great job in developing the plan that states how we will care for up to 80 patients. Brookings Health is in the process of purchasing a blood analyzer to test for COVID that has the ability to process results in about an hour, however, obtaining testing supplies for the analyzer may be a challenge.

Governor Noem will address the State tomorrow to explain criteria associated with lifting some of the current restrictions. Hospital leadership has also begun discussions on reopening and will roll out some messaging on the same in the coming days.

Brookings Health is planning and preparing for a new normal in the face of this crisis and will be implementing measures to temporarily reduce workforce expenses. This will include PTO/low-census for patient-facing workers in areas that are seeing lower volumes and mandatory reduction in hours of other ancillary/support and administrative staff as well as a hiring freeze.

Merkley also commented there continues to be an abundance of businesses and individuals who have reached out to donate to hospital staff and the local Boys and Girls Club is working towards being able to provide daycare for our staff and first responders. We are very grateful for their generosity.

## **Board Meeting in May**

The Board previously agreed not to meet in the month of May, however, in light of the current situation, a recommendation was made that the Board of Trustees meet in May for an update on financials and COVID-19; all members were in agreement.

A motion was made by Darnall, seconded by Krogh to hold an abbreviated Board of Trustees meeting in May that will focus on April financials and an update on the COVID-19 impact to Brookings Health System.
