Jacob reported on following:

the electric charging station: From June 22 to the end of the year there have been 45 uses, averaging each one hour. The City earned \$125. Jacob is tracking legislation updates. Most of those adversely affecting the city have failed. The issue of a fee on electric vehicles might have more momentum as part of the green energy standards for the state.

There will be city council elections in April, with the Mayor and 2 city council positions open.

There is an “engage Brookings” app and a street light app has been added.

The Master Plan for parks is continuing until June 2021 and the city is collecting surveys.

Strategic Plan was approved last meeting. Each subcommittee should meet by next month and start to develop goals and a plan to meet their goals. Also, each committee should look to training opportunities in each sub category.

Todd Langland gave a report on the landfill.

There was a small drop in tonnage and in revenue because there were fewer big constructions projects in 2019. The collection report was good—more new homes meant more garbage and more compliance. Compost is up a lot and with the cart system that will grow. Recycling is down about 3 tons from 2019. Don't know why, but recycling should grow in 2021.

Gross revenue in 2019 was \$1,169,418 compared to 2020 \$1,185,290.

Plastic bag use is down a lot, which is a good sign, although there still is concern with multi house and commercial entities.

The Sioux Falls recycling facility that we send our recycling to likes our residential recycling and has commented that our material comes in clean.

Brookings Solid Waste now accepts glass and we could educate better on this.

Update on the **Citizen Campus** for yard waste recycling: It opened the end of August and went well. Todd didn't see illegal dumping and said people were respectful. It has been used heavily. It shut down in December and will open again March 20, 2021.
