#### **Informational Items**

Merkley commented on the article "Connecting to Caregivers" referencing how medical staff are coping with the COVID-19 pandemic. It is more important than ever how we take care of our staff on the front lines; their wellbeing is critically important. Brookings Health System is not immune to the country's nursing shortage due to compassion fatigue, stress and burnout.

# **Executive Reports**

### **CEO Report**

Merkley noted Brookings Health System Foundation's twelfth annual Aiming to Inspire sporting clays fundraiser was a great success despite the ammunition shortage. \$17,000 was raised to support local healthcare through BHSF. Discussion also took place regarding two new lab tests (Vitamin D and Vitamin B12) that have been brought in-house for the chemistry analyzer in the laboratory. There has been an increase in these orders over the last few years and it's a financial benefit to process these tests in-house versus a reference lab.

#### **CFO Report**

Wagner highlighted results for the Medicare Cost Report filed for 2020. A small settlement payment will be issued to CMS/Noridian due to overpayment. Wagner also noted Director of MHI, Pam Weckwerth, will be retiring in September after 33 years of service. Evaluation is being done on potential ways to restructure the Medical Health Information department.

### **CNO Report**

Hillestad commented Emergency Department Director, Karen Weber, advocates for and leads the organization in behavioral health and opioid misuse awareness and has been asked to serve on the OUD (Opioid Use Disorder) Advisory Board, part of the START (Stigma, Treatment, Avoidance and Recovery in Time) SD federal program. START SD is funded by Health Resources and Services Administration (HRSA) and is working to increase access to prevention, treatment and recovery services in Brookings, Codington and Hughes Counties. Brookings Health will serve as a pilot site for a resource toolkit to help reduce abuse and misuse of opioids. Hillestad also noted, sadly, our internal COVID task force is working on updating the surge plan and reeducating staff on medical treatments for COVID patients.

# **Board Committee Reports**

### **Administrative Committee**

Committee member Morgan provided a report; the Administrative Committee met on August 24, 2021. Topics of discussion included Brookings Health System's Strategic Plan, da Vinci Robot Xi, Workforce Strategy/Salary & Wage Survey, Board Nominee/Reappointments, Inpatient Coverage\Hospitalist, Supplemental Executive Retirement Plan (SERP) Accounting Balance Sheet, COVID Update/Vaccinations/Meeting Format and Annual Review of Board and Medical Staff Bylaws and Quality Assessment and Performance Improvement Program.

### **Finance Committee**

Committee Chair Peterson provided a report; the Finance Committee met on August 26, 2021. The committee reviewed and approved the payables, adjustments and financials for June and July. The Committee also discussed the da Vinci Xi Robot and wage adjustments which are based on the annual market survey data from SDAHO and other sources.

### **Ouality Committee**

Quality Committee Chair Ellsworth provided a report; the Quality Committee met on August 24, 2021. Topics of discussion included the Q4 2020 Clinical Quality Dashboard, Provider Star Ratings, O1 2021 Service Line Performance Report and a COVID Update.

## COVID-19 Update

Much discussion took place on COVID-19 and vaccination efforts/mandates. Ellsworth noted, it appears Avera Health will come forward soon announcing the mandate of the COVID vaccine with a similar timeline as Sanford Health. Members feel which ever route is taken, further staffing shortages could take place either due to illness or vaccine hesitancy. The AHA (American Hospital Association) is encouraging vaccination and many in the healthcare industry feel it's the right thing to do. Merkley stated we are in close collaboration with the City, SDSU and local clinics and as we continue to push forward on all decisions relative to COVID. Internally, we are reviewing protocols and procedures and getting ready for what may be heading towards us. On a positive note, Merkley noted, we are seeing an uptick in the number of people seeking the vaccine within the community and immune compromised individuals are beginning to receive the COVID booster.
